► Cover Story - by George Lafontaine



One of my most interesting covers obtained last year is this December 17, 1948 War Issue cover mailed from the Toronto Air Mail Section to Kesumu, Kenya. The correct rate was 50 cents per 1/2 ounce resulting in a short-paid cover of 25 cents. In Canada the 150 centimes was applied: 25 x 3 centimes per cent double deficiency then converted to 120 cents in Kenya. On January 7, 1949 three 40 cent KUT postage dues are shown tied to cover.

Cachets for Peace Issue First Day Covers

Mike Street's recent study of the rates and postal history of the 1946 Peace Issue (1) devoted a chapter to First Day Covers (FDC's). He presented fourteen covers representing a variety of different destinations and rates, but only two of them depicted cacheted envelopes. This was an appropriate selection given the focus of Street's study, but it did not reflect the main interest of those philatelists who choose to specialize on the FDC cachets rather than the rates and destinations of the covers. The purpose here is to present an overview of the cachets that were used to embellish the day of issue envelopes of the Peace set.

The great majority of cachets for the Peace set have been documented by members of the FDC Study Group and are included on that group's website (2). For the purpose of this study, the relevant cachets were downloaded to the author's computer in a separate file and duplications were deleted.

The result of this process was that almost 50 different cachets were identified consisting of 28 general purpose cachets (usable for any stamp issue of the era) and 20 special purpose cachets designed specifically for one or more of the Peace issue stamps. Colour varieties of some designs were noted but not included in the above totals. Thus, **Miss W.R. Smith** of Toronto used three basic designs with at least eleven colour variations while the **Artmaster** and **Fulton** Company cachet designs each had seven colour varieties. Fulton was the only producer to make a different colour or design of the cachets for each stamp in a set.

Very few FDCs carried the complete Peace set comprised of nine stamps (Scott # 268-273, C9, CE3, and E11), in part because a #8 envelope would barely have room for them all. Complete day of issue covers are usually found on a #10 or (larger) envelope. For example, the cover shown in Figure 1 carries the complete Peace Issue set of nine stamps on a #10 envelope. All of the stamps are tied to the cover with Montreal Place d'Armes CDS cancellations dated September 16, 1946. There is a red rubber-stamped "First Day Cover" cachet along with "Registered", bilingual "Special Delivery" and registration rubber-stamped impressions.

The U.S. firm Artmaster produced a cachet that was printed in black and showed symbols of Canada that were representative of the scenes that were shown on the definitive stamps. The Ottawa registered cover shown in Figure 2 carries a block of CE3 stamps and was addressed to Philadelphia. The plain black cachet was hand-coloured and is one of several different versions of the Artmaster cachet that received a similar treatment.

The renowned cachet maker **Ludwig Staehle** also included some peacetime symbols drawn from the definitive stamps but also noted “Victory” on his cachet design. The cover in Figure 3 was printed in red but the same design was also printed in dark blue.

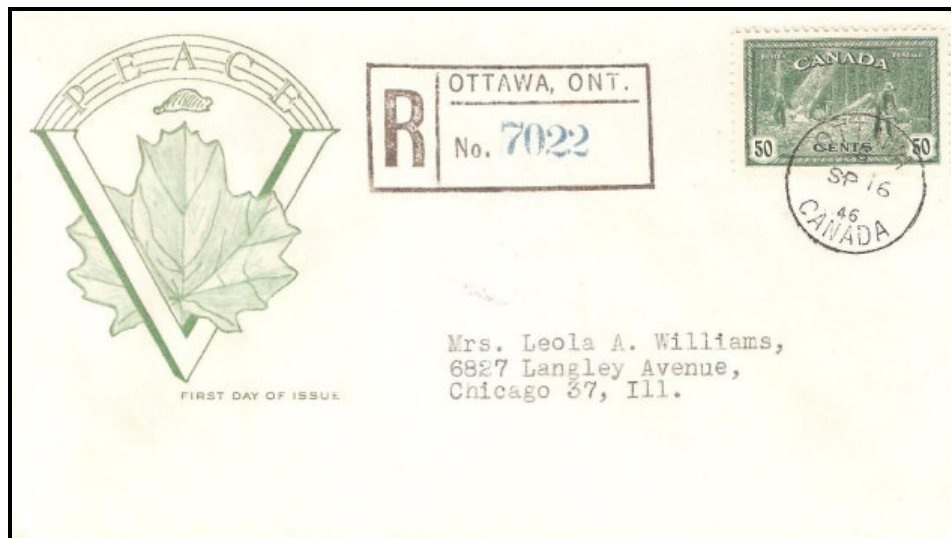
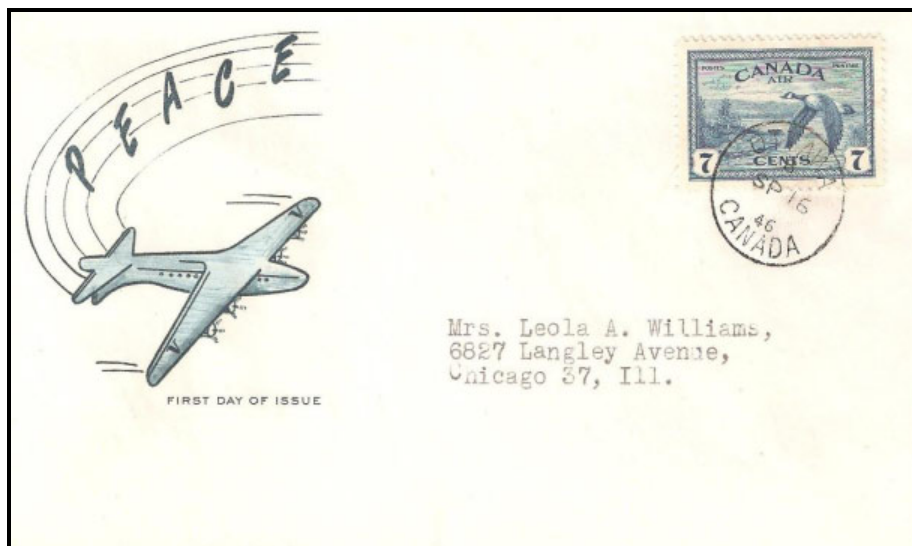


Figure 4: Green Fulton cachet with # 272

The **Fulton Stamp Company** used two different designs for its' cachets. The design used for # 268-273 was as shown in Figure 4 (see page 5) on a registered cover to Chicago, but the cachet for each stamp was printed in a colour similar to that of the stamp (3). The two other stamps (C9 and CE3) were given a different design featuring an airplane flying upside down as illustrated in Figure 5.

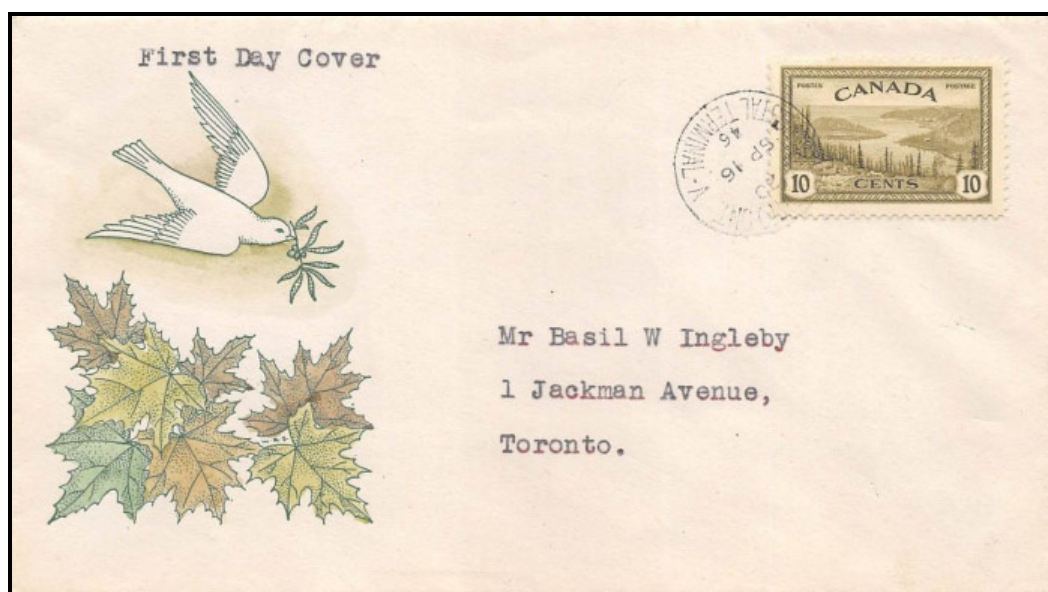
Figure 6: Merrihew general purpose cachet with #E11

Winnipeg's **M.J. Merrihew** produced a general purpose cachet that was used for many stamp issues in 1946 and later years. Illustrated in Figure 6 the Merrihew cachet's design was based on the stamp (E11) that was affixed to this cover. Although most of his FDC's were postmarked at Winnipeg, this example was mailed at Toronto's Terminal A and the franking included the 3 cent King George VI coronation commemorative (Scott # 237)

Another general purpose cachet that saw use for the Peace Issue was that of the **Windsor Stamp Collectors Club**. It is shown in Figure 7 with # C9 and a Windsor postmark



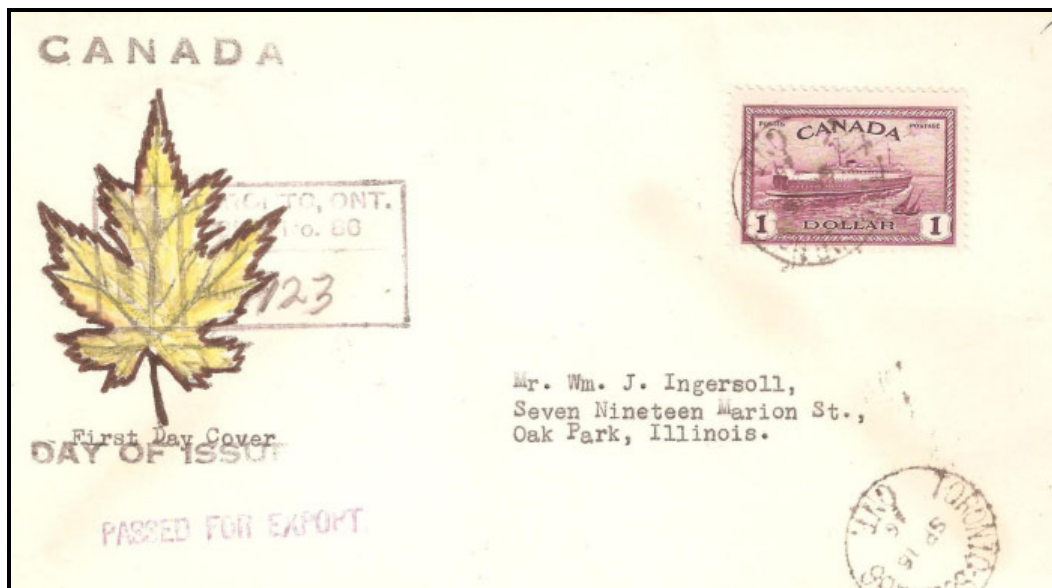

Toronto resident W.R. Smith was an active producer of FDC's in limited quantities for Canadian stamp issues between 1939 and 1950. She employed only three basic designs throughout that period, but all of her FDC's were finished by hand with text or water-colours or both so that each cover had a different appearance even though the foundation was the same. Most, but not all of her cachets for the Peace stamps used her Type III design (4) including the one shown in Figure 8 which was addressed to a Toronto resident and mailed at that city's Postal Terminal A.

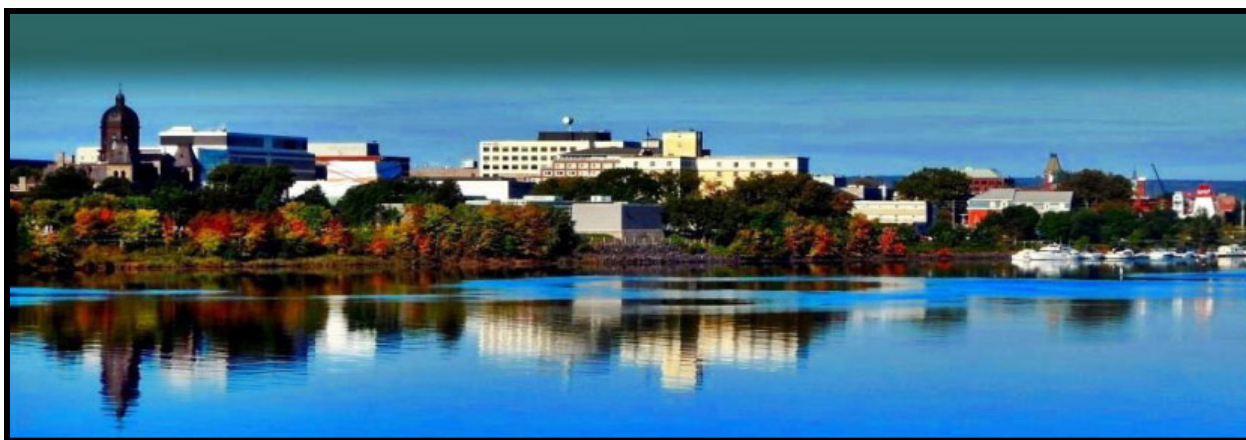


**Figure 9: Wright

The final cover (Figure 9, page 7) was an unusual add-on, and it took several inquiries to find out its background. It appears on numerous FDC's over many years, and dates back to covers from the 1920's. The cachet consisted of a hand stamp made by **Ted Wright**, who was an employee of the **George Wegg** firm. Wright indicated to **Bob Vogel** at a stamp show in Barrie, ON., that, "Whenever I found an uncacheted FDC with plenty of white space, I would apply the hand stamp and colour it (5).

The Role of Canadian Banks in Assurance of FECB Compliance (Part 6)

Order in Council 2716 – Foreign Exchange Control Order and Regulations (September 15, 1939) Section 32 (1) states:

“Every bank incorporated under the Bank Act shall be an authorized dealer in Canada, and every Canadian branch of such a bank shall have the powers and duties of an authorized dealer pursuant to this Order”. [1]

The banks were given the authority to self-approve all outgoing mail provided it met regulations, was marked on the face with the return address of the institution, was initialled by an officer of the institution and was endorsed

AUTHORIZED FOR EXPORT BY

FOREIGN EXCHANGE CONTROL BOARD

The authorization was communicated to the banks by telegraph and confirmed, together with “*suitable instructions given to Postmasters and Collectors of Customs*” by Deputy Governor **D. Gordon**. I assume all banks received the same correspondence as that addressed to The Canadian Bank of Commerce on September 19, 1939 [2] and consequential “Special Instructions to Branch Banks”.

Recognizing the neutral position of the United States of America and the volume of cross-border financial transactions, FECB Chairman **Gordon F. Towers**, by letter dated September 15, 1939 advised the Chairman of the Federal Reserve System, **Hon. Marriner S. Eccles**, the details of the measures being taken by Canada and the role of the Canadian postal service and chartered banks as related to such transactions. [3]

As will be noted a wide variety of authorization declarations may be found. The authorization can be found in “manuscript form”, “typewritten form” and in “hand-stamp form”.

Bank of Canada

The Bank of Canada acts as “*technical advisor and banker to the Board, which will have at its disposal initially the assets of the pre-sent Exchange Fund*”. [3]

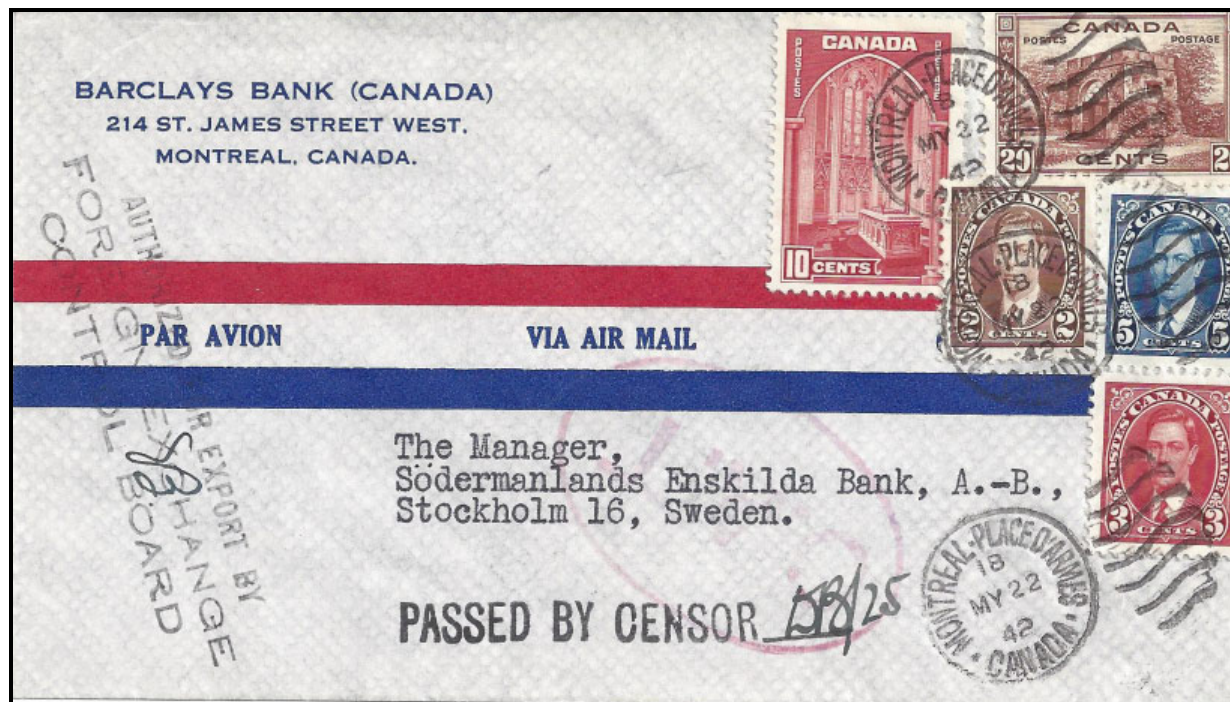
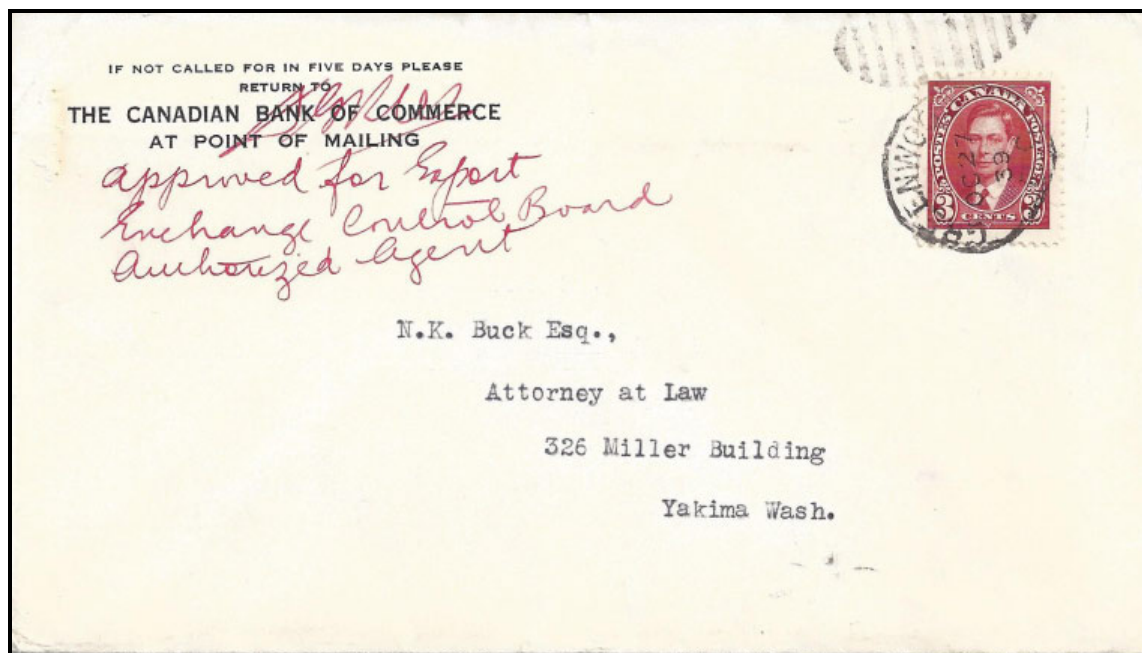

Canadian Bank of Commerce correspondence mailed from Greenwood, BC to Yakima, Washington with **manuscript endorsement** on October 27, 1939.

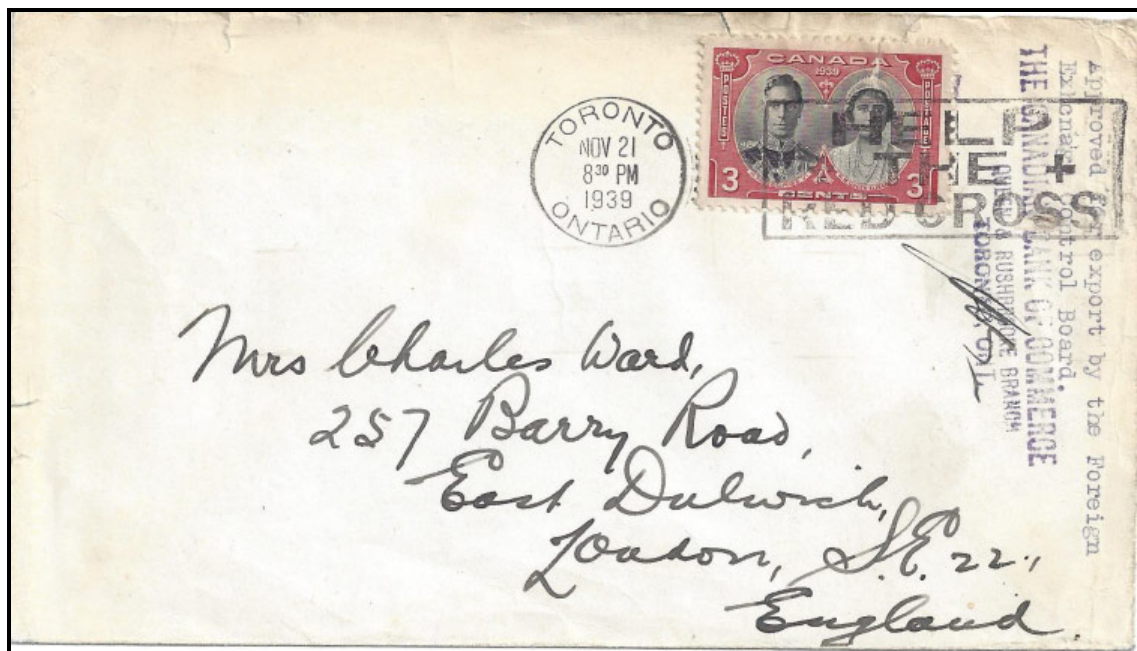


Figure 3a: Canadian Bank of Commerce correspondence mailed from Toronto to London, England on November 21, 1939 with a combination **Typewritten “Approved...”** and Bank Hand Stamp. Note the use of the word “Approved”, wording generally used by trust and insurance companies, and the incorrect spelling -**“Exhcnage”**.

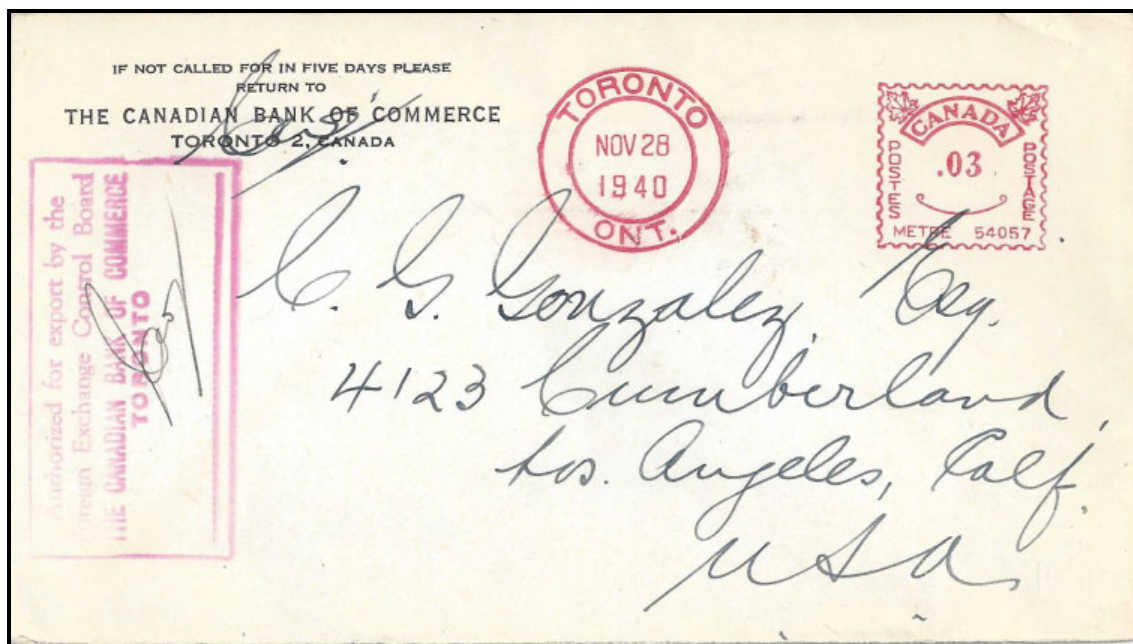


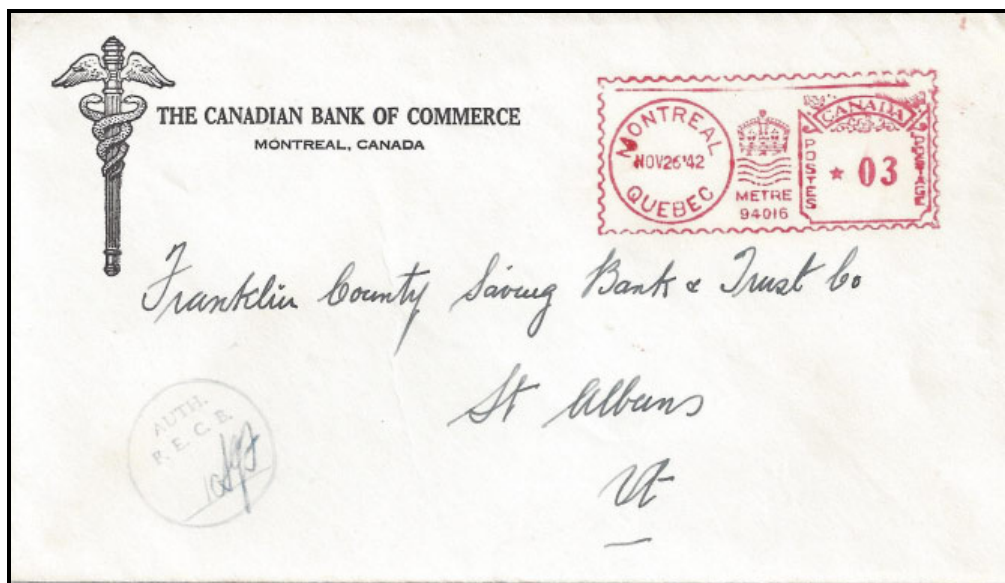
Figure 3b: Canadian Bank of Commerce correspondence mailed from Toronto to Los Angeles, USA on November 28, 1940 using a “BOXED” hand stamp.

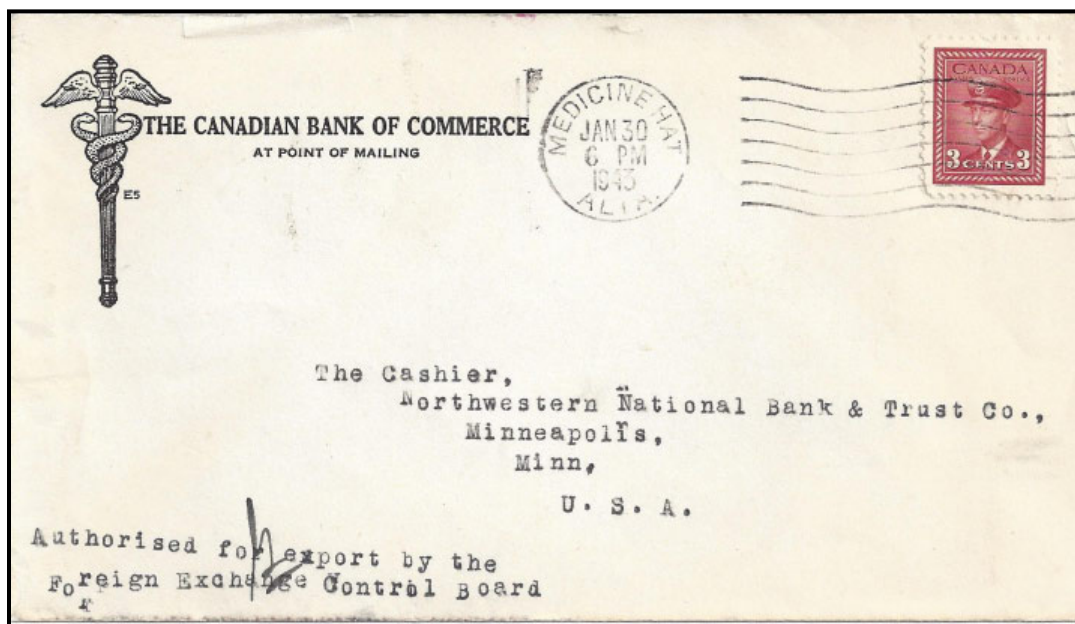
Canadian Bank of Commerce correspondence mailed on May 15, 1940 from Princeton, BC to the Chase Bank, Hong Kong, China.

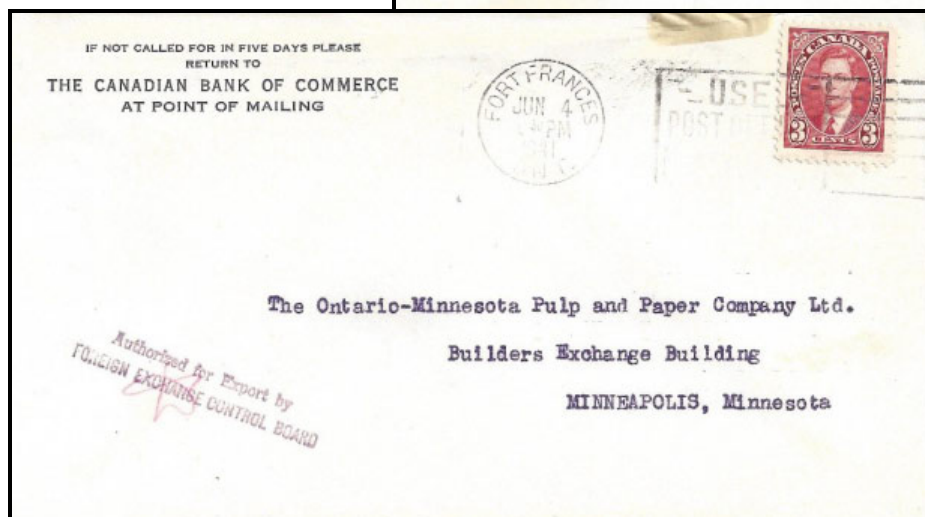

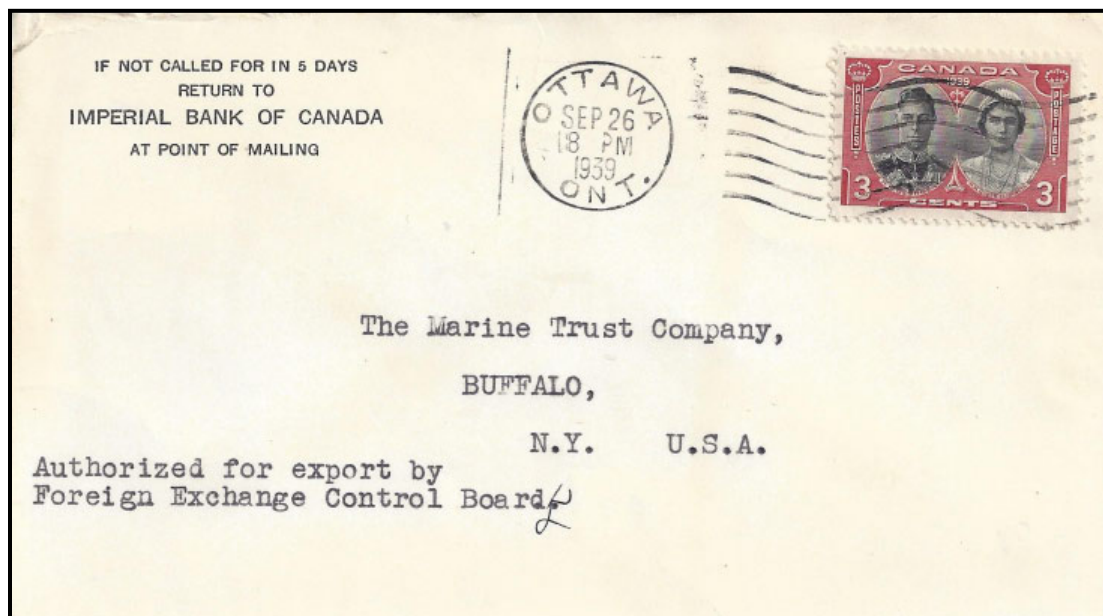

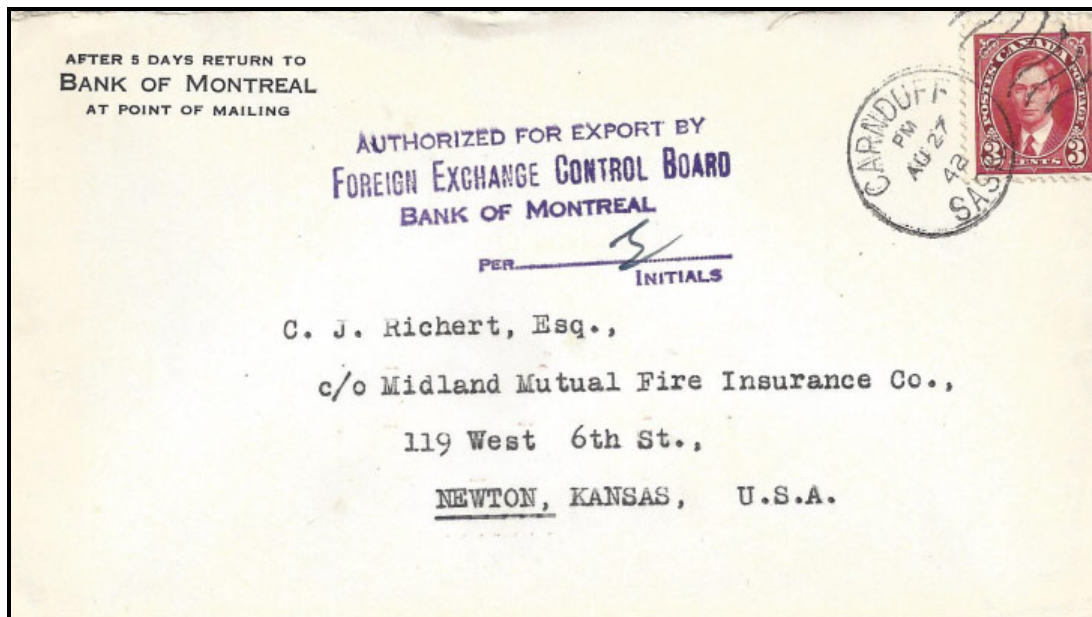

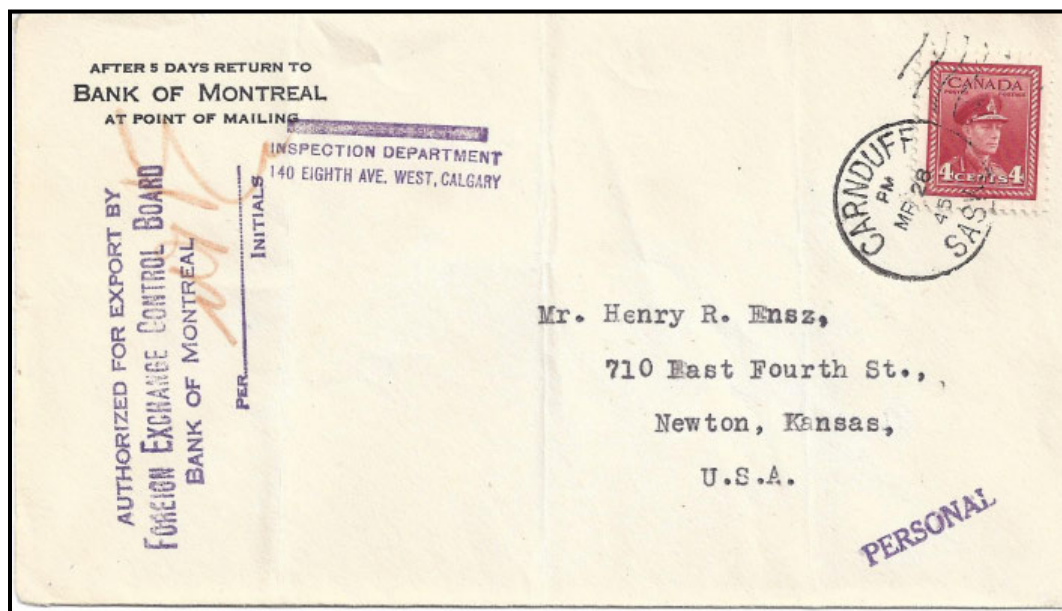

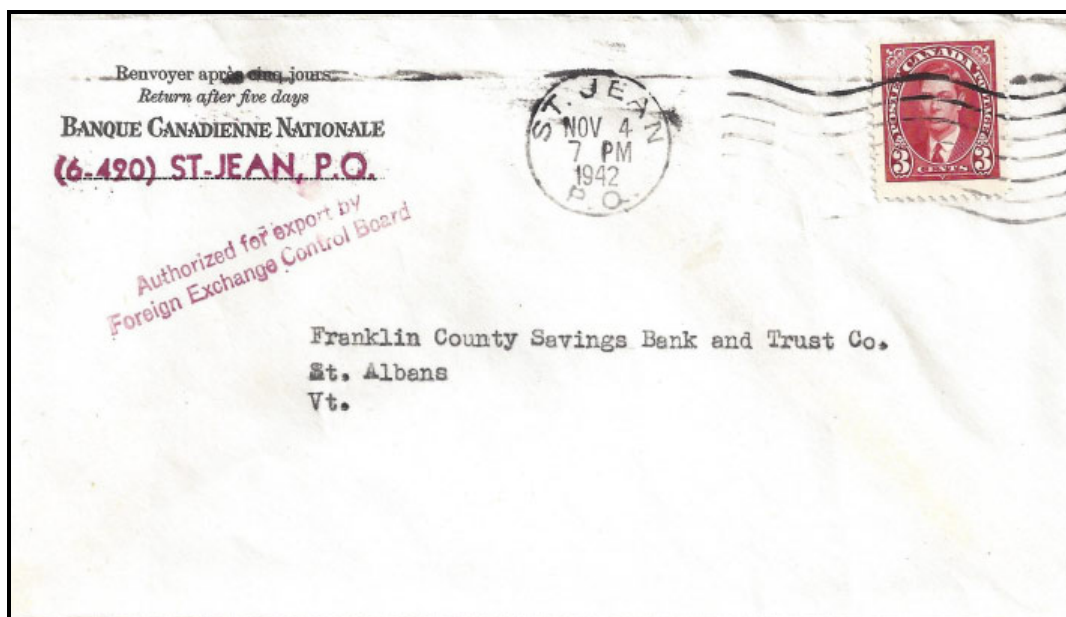

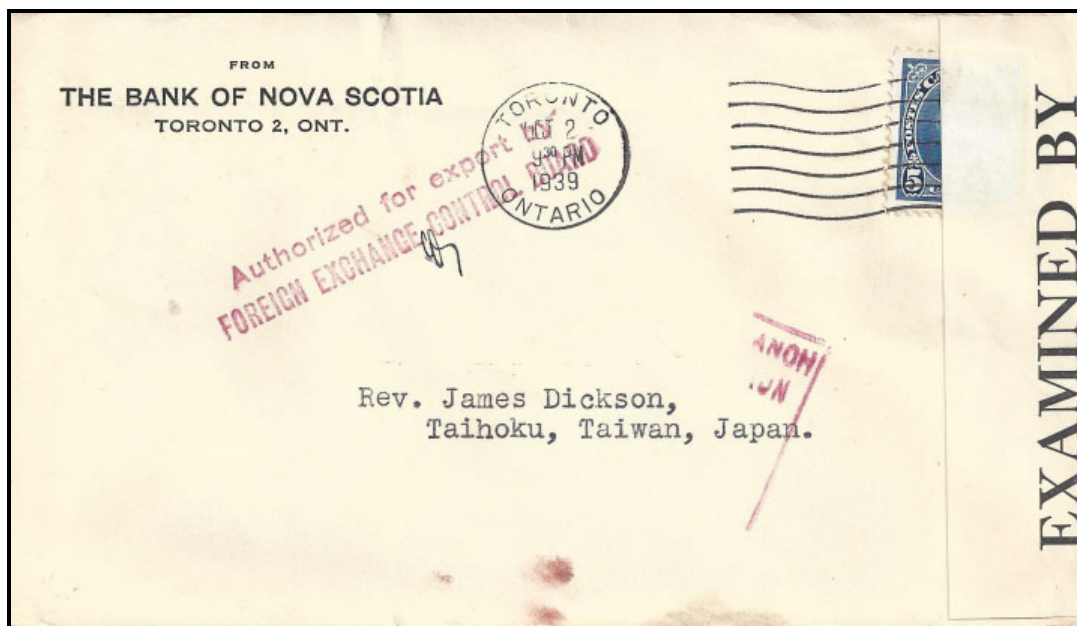
**Figure 6b:**

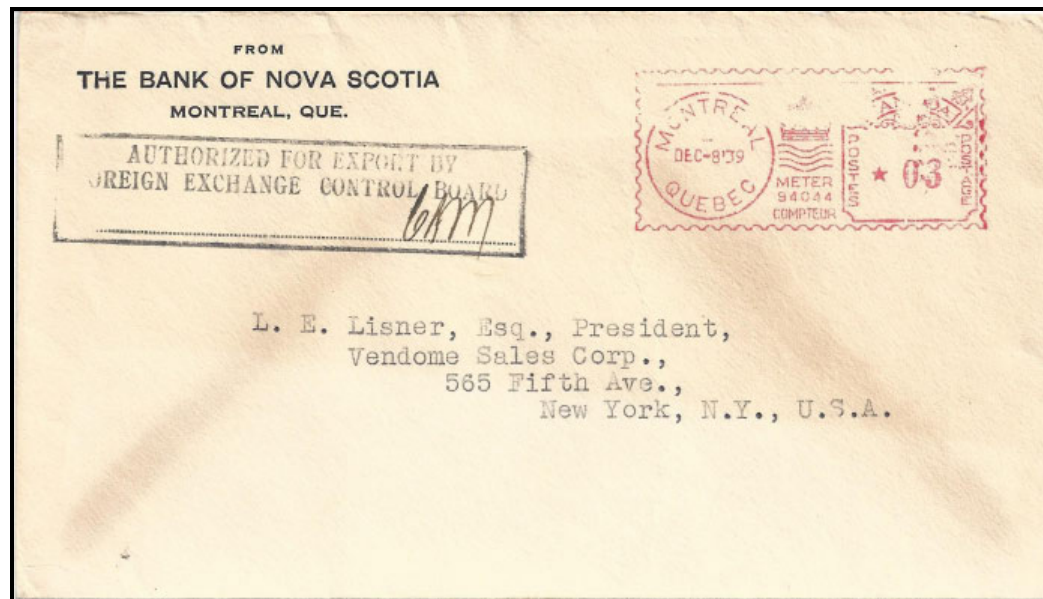

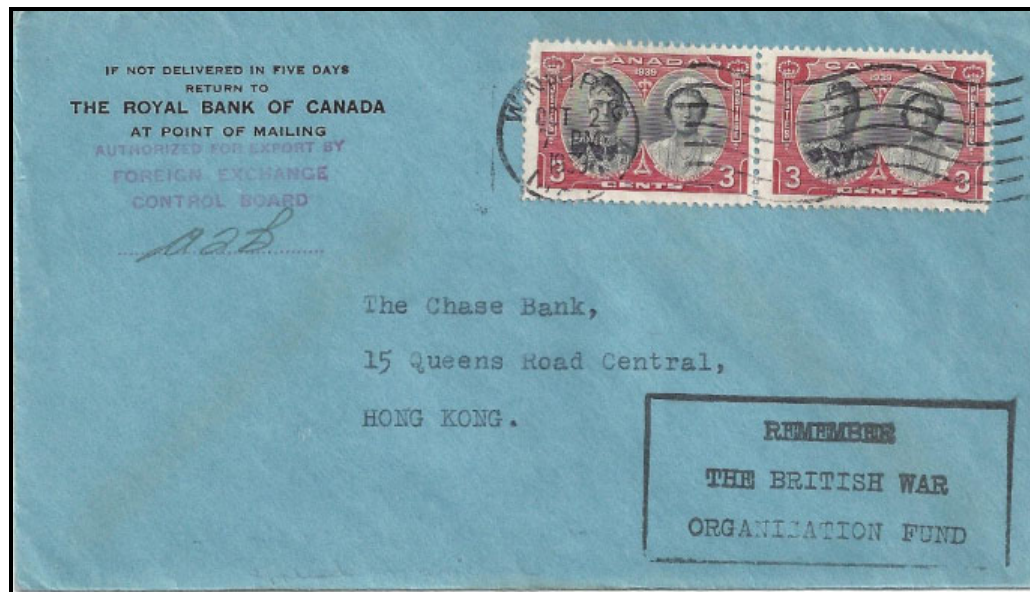

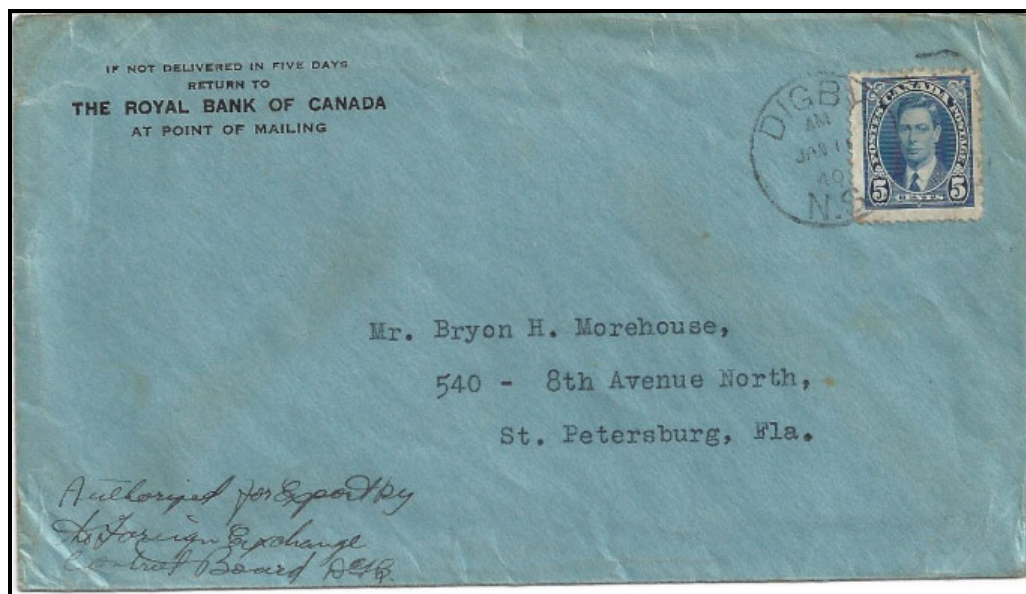

On April 1, 1939 the Empire Air Mail Scheme (EAMS) was extended to Hong Kong.

With the outbreak of World War II the EAMS was discontinued in September 1939. This correspondence dated October 2, 1939 appears to have gone forward as under the EAMS regime.

Royal Bank of Canada correspondence mailed on January 20, 1940 from Digby, N.S. to an individual in St. Petersburg, Florida, U.S.A. Note the *Manuscript Endorsement* used at this relatively small post office.

Note PASSED BY CENSOR 52 (Ottawa) and also by Greek Censor.

Note PASSED BY CENSOR DB/610 (Ottawa).

It should be remembered that every branch of the banks were required to abide by the regulations – branches in communities as small as “Greenwood, B.C., Carnduff, Sask., and Digby, N.S. required endorsement of compliance just as branches located in the cities of Toronto and Montreal.

The above illustrations provide an overview of possibilities for the collector of bank correspondence during World War II while exchange transactions were under the control of the Foreign Exchange Control Board. Post-war requirements will be noted in a later part of this series.

In Part 7 we shall look at endorsements of compliance by Trust Companies and Insurance Companies.
